

Remove existing metal roof & existing snow guards (one layer metal/felt) and properly dispose of. Install Grace and/or Titanium high temp ice&water shield to the entire roof deck. Install 26ga Premium Lock 150x16" mechanical seam standing seam metal roof system (color: standard) in accordance with manufacturers specifications for high wind installation, complete with new matching flashings of: eave, gable, W-valley, sidewall, vented endwall & vented ridge flashings. Associated details to include: custom septic vent pipe flashings, high wind ridge ventilation, associated clips & screws, matching rivots, exhaust vents, new stove jacks/collars and matching touch up paints. Install any final butyl

screws, matching rivots, exhaust vents, new stove jacks/collars and matching touch up paints. Instant any matching touch up paints.

This contract may be cancelled within seventy-two (72) hours after signing with a full refund of any deposit that has been paid up front. After 72 hours, cancellation of signed contracts will have a minimum of 10% of the total contract recovery fee for time & materials invested. Proposal is valid for acceptance for 30 days. R&R Roofing & Siding, Inc. shall hold in trust any payment from the property owner until we have delivered the roofing materials at the residential property site or have performed a majority of the roofing work on the residential property. **Price changes in materials cannot be guaranteed at any time prior to acceptance.**

Payment Terms:

Balances and/or financed payments not paid within 10days of completion or dues dates, will be charged a late charge of \$25.00 and an 18% APR, compounded monthly, unless other terms have been agreed upon. Accounts not paid in full in 30 days will have a mechanics lien placed against the said property, with all associated expenses incurred in collection of the funds, including all attorney fees being the sole responsibility of the customer. All delinquent balances will default to maximum interest penalty per Colorado law. In the event third party financing is arranged, all payments and/or agreement terms are to be sent directly to the lending source. R&R Roofing & Siding Inc. does not directly accept payments for third party financing.

Insurance claims:

If the property owner plans to use the proceeds of a property and casualty insurance policy issued pursuant to Part 1 of Article 4 of Title 10, C.R.S., to pay for the roofing work, we cannot pay, waive, rebate, or promise to pay, waive, or rebate all or part of any insurance deductible applicable to the insurance claim for payment for roofing work on the covered residential property.

HOW TO PREPARE FOR A ROOFING JOB AND WHAT TO EXPECT

1. When shingles and/or metal panels are delivered to your home or project, please check the color. Notify R&R ROOFING & SIDING, INC.

("R&R") immediately if the color is not what you ordered.

2. Be prepared for the noise! There will be constant hammering for one or more days.

3. Keep small children and pets away from the work area.

4. Remove all loose items from wall shelves and walls: pictures, plates, figurines, etc. Hammering may create vibrations that may shake these items off the shelves or walls. Vibrations may cause nail pops or stress fractures in the drywall. Unfortunately this rare damage is unavoidable. Consult your salesman for options.

5. Remove all items from around the house/project where roofing debris or bundles of roofing might fall: patio furniture, potted plants, gardening equipment, etc. Leaves or blooms may be knocked off the plants near your home during the job. We do our best to protect the plants, but occasionally the layout of the landscape prevents us from doing so. All shrubbery must be at least 2 ft. from the roof deck. Consult your salesman for options. 6. We will need access to your driveway to load materials and clean up. Please park your cars, motorcycles, bicycles, boats, etc. away from the driveway. Avoiding this area is recommended until completion of the project.

7. We will use power tools during the roofing process. Please check your power breakers & GFI receptacles to make sure they are operating correctly and are not tripped. Damaged pre-existing faulty fixtures/faceplates should be noted. There will be additional costs for use of generators to provide adequate electricity.

8. During the roofing project, R&R will be placing tarps on decks and sidewalks to help avoid any exterior damage. However interior tarping of attics and/or furniture must be the responsibility of the customer to protect against any dust or debris. Carefully consider protecting areas beneath skylight installations.

9. Precautions are taken to prevent gutter damage. However, there are instances when damage to gutters is unavoidable, especially on very steep roofs or old installation techniques. Consult your salesman for options.

10. Given our mountain climate and untimely rain & snow, tarps are always on site to aid in temporary water-proofing of roofs. Many county jurisdictions require full "dry-in" inspections, thus the house/project may only be protected by the underlayment for a short period of time. Extreme inclement weather may compromise the temporary water tightness, but all measures are taken by all employees of R&R to protect the integrity of the house/project.

11. Indirect & undetected loosening of heater vents may occur during the replacement of associated vent flashing. A Carbon Monoxide detector (to be installed by customer) will be provided by R&R to ensure your safety. Improper pre-existing installations or attachment of vent pipes cannot be the responsibility of R&R.

12. Nails or screws from the project will be picked up with a magnetic nail roller. We will make every effort to pick up all fasteners. Please be advised, however, that a few nails - often hidden in the landscaping - may remain.

13. Occasionally existing roofing has been sealed to the sidewalls. During the removal of roofing along walls, paint removals and chipping of the stucco or wood may occur. In some cases pre-existing fascia trims are not installed with the plane of the roof and additional repairs may arise. Some minor additional costs may be necessary. Consult your salesman for options.

14. When the old roofing is removed a tremendous amount of weight is taken off the frame of your home.

This can cause slight movements of your rafters and beams. This shifting may cause small stress cracks in your ceiling along with paint popping off nail heads. R&R is not responsible for this unavoidable occurrence.

15. Sagging, deterioration, bubbling, water saturated decking, and/or moldy, deteriorated or cracked rafters may

be exposed with the removal of the existing roof. Multiple layer tear-offs will magnify these imperfections. These unforeseen repairs will require additional costs as these repairs are mandatory per building departments and manufacturers to insure adequate roof structure & assembly. Consult with your salesman for pricing.

16. It is recommended that if the project contains any solar heating and/or electrical components, that you consult a licensed/certified solar contractor to provide all removal and reinstallation. Ask your salesman for options.

17. Customer agrees to hold R&R harmless for fastener penetrations and/or damage to personal property, security, or electrical lines, and equipment closer than 3 inches to the underside of roof deck.

18. Make all payments to R&R ROOFING & SIDING, INC. Please do not make checks payable to the salesman.
